



## • IS CANNABIS CONSUMPTION LEGAL?

The State of Hawaii only allows medicinal cannabis consumption. Recreational consumption is illegal.

To purchase medicinal cannabis, you must first apply for the Medical Cannabis Registry program. The program certifies patients and issues medical cannabis patient cards, also known as a 329-card. A 329-card is issued to both residents and non-residents that meet the requirements of the program, and grant cardholders entry into a medicinal dispensary.

Entry into a dispensary by an individual that is not a part of the Medical Cannabis Registry program is strictly prohibited.

A valid 329-card and a government issued state ID, driver's license, or passport must be provided at reception.

## E KOMO MAI

Once you receive your 329 card visit one of our dispensaries to enjoy our, "E Komo Mai" or Welcome package.

This new patient program is offered to first time buyers and will provide you with a \$100 store credit to help you recoup the costs of your 329 card (applies to renewals as well).

# HOW TO GET YOUR 329 CARD



## HOW DO I JOIN THE PROGRAM?

- Select a participating provider at [www.noacares.com](http://www.noacares.com)
- Call to schedule an appointment
- Prior to your appointment, submit an online 329 application at <https://medmj.ehawaii.gov> using a valid email address
- Follow all the steps including assigning a caregiver, uploading all documents, and submitting payment for the application fee
- Once the medical provider certifies that you have a qualifying condition using the state portal you will receive an electronic 329-card
- If you chose to submit your application using a printed form that is submitted via mail, then you will receive a printed copy of your card in the mail.

*Processing times may take up to 2 or more weeks.  
Check the state website for current wait times.*



## WHO CAN JOIN THE PROGRAM?

Participants must be 21 years or older and minors require consent from both parent

### Residents

Must be certified as having one or more debilitating medical conditions recognized in Hawaii by a licensed physician/advance practice registered nurse (APRN)

### Non-residents

Valid Medical Cannabis Registration card issued by the patient's home state/territory

International travelers are not allowed in the program at this time

Each cardholder is allowed to designate one caregiver. Caregivers are extended purchasing privileges that do not require the cardholder to be present.

## WHAT ARE THE QUALIFYING CONDITIONS?

The specific conditions that are recognized by the state include:

Amyotrophic Lateral Sclerosis

Cancer

Glaucoma

Lupus

Epilepsy

Multiple Sclerosis

Rheumatoid Arthritis

Positive status for human immunodeficiency virus

Acquired immune deficiency syndrome

Post-traumatic stress disorder

Treatment of these conditions may result in symptoms that are also considered a qualifying condition:

Cachexia or wasting syndrome

Severe pain

Severe nausea

Seizures, including those characteristic of epilepsy

Severe and persistent muscle spasms, including those characteristics of multiple sclerosis or Crohn's disease
