

IS CANNABIS LEGAL IN HAWAI'I?

The State of Hawai'i currently allows for the medical use of cannabis. Recreational consumption is illegal.

Hawai'i law requires all qualified patients to be registered with the Medical Cannabis Patient Registry Program and obtain a 329 card before they begin to use cannabis for medicinal purposes.

Access to Noa Botanicals and other State-licensed medical cannabis dispensaries in Hawai'i is limited to holders of a 329 card.

HOW TO GET YOUR **329 CARD**

WHO CAN JOIN THE PROGRAM?

Participants must be 21 years or older and minors require consent from both parents.

Hawai'i Residents

Must be certified as having one or more qualifying medical conditions recognized by the Hawai'i Department of Health and certified by a licensed physician or advance practice registered nurse (APRN).

Out-of-State

Must have a valid medical cannabis registration card issued by another U.S. state or territorial or District of Columbia government and certified as having one or more qualifying medical conditions identified in Hawai'i State Law.

WHAT ARE THE QUALIFYING CONDITIONS?

In Hawai'i, the Department of Health has defined the following qualifying medical conditions:

Amyotrophic Lateral Sclerosis

Cancer

Glaucoma

Lupus

Epilepsy

Multiple Sclerosis

Rheumatoid Arthritis

Positive status for human immunodeficiency virus

initial odericiency vira

Acquired immune deficiency syndrome

Post-traumatic stress disorder

Treatment of these conditions or a medical condition that produces one or more of the following are also considered a qualifying condition:

Cachexia or wasting syndrome

Severe pain

Severe nausea

Seizures, including those characteristic of epilepsy

Severe and persistent muscle spasms, including those characteristics of multiple sclerosis or Crohn's disease

HOW DO I JOIN THE PROGRAM

1. Schedule an appointment with a certifying physician / APRN View our list of certifying providers here



2. Fill out the online application Create an account on **medmj.ehawaii.gov** Upload required documents (valid ID)

4. Pay the Application Fee

The cost is \$38.50 and can be paid with a credit/debit card or direct withdraw from savings or checking account.

5. Submit your application

Once your physician / APRN certifies your qualifying medical condition and submits your application to the Hawai'i Department of Health, it will be in queue for processing.

6. Get approved

Once your application is approved, you will receive an email notification. Log into your account on **medmj.ehawaii.gov** to download your electronic 329 card.

Processing times may take up to 2 weeks or more. Visit the State website for current processing times.

7. Visit Noa Botanicals

Bring your electronic or physical 329 card and a valid government-issued photo ID.
